



Alexandra Ski Club New Member Information & Application Form



Background

In 1960 the idea of Alexandra Ski Club was first mooted by a small group of friends, eager to obtain an alpine recreational facility for their families. By Easter 1961 the Lodge construction was complete, with eleven families as the original shareholders. The Lodge was named in honour of HRH Princess Alexandra of Kent who had been a recent visitor to Australia. Her permission was duly sought and from these small beginnings, Alexandra Ski Club was born. The Lodge footprint and layout remains mostly the same since its origins.

By 1978, membership had grown to 99 families and the first of a series of major renovations were undertaken. By 1999, the last phase of a 10 year renovation program was completed, with major improvements to the kitchen, bathrooms, ski entry and bedroom configurations, with membership at around 180 shareholders. The incredible vision of the group of original members has ensured the current membership enjoys a comfortable not for profit private ski facility where the bonds of friendship and active snowsport are encouraged. The majority of current shareholders are 2nd or 3rd generation descendants from the original members in the formative years.

Location

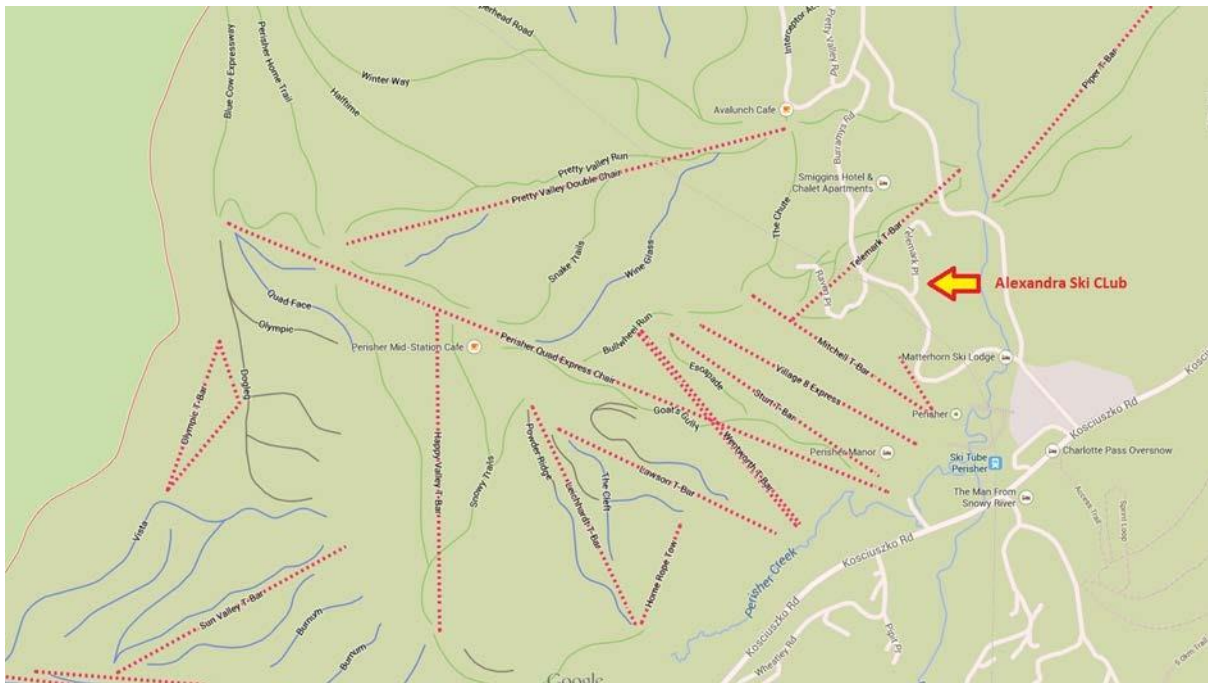
Alexandra Ski Club is perfectly positioned as a truly ski in/ski out lodge, located in Telemark Place, on the northern side of Perisher Valley, NSW.

The prime location allows for first run access by skiing down to the nearby Telemark T-bar, which lifts to Front Valley, from where the entire resort is accessible. Smiggins Holes can also be directly accessed by skiing down to the Piper T-bar. You can ski home to the front door via the back of the Sundeck Hotel.

Perisher Resorts encompasses Perisher Valley, Smiggin Holes, Blue Cow and Guthega all interlinked by chairlifts and T-bars, accessible on the same lift ticket.

Access to the resort is either by paved road or SkiTube train from Bullocks Flat, which is on the Thredbo access road. From the Ski Tube terminal or carpark, access to the lodge during the winter time is via oversnow 'cats' operated by Hans Oversnow.

Facilities

The Ski Club has nine bedrooms with 5 shared bathroom and 4 showers over two levels, commercial kitchen and spacious living areas. There is also a ski and drying room, plus laundry facilities. There is a large panoramic window in the lounge room, offering beautiful views of North Perisher (see photo above), which opens on to a sizable deck, complete with outdoor setting and BBQ facilities.

The lounge room has several leather lounges and an open fire, with an additional separate games room for children, complete with a table tennis table.

The lodge operates on a self-catered basis, with families bringing in their requirements for their stay. The kitchen is quite large offering multiple preparation and cooking zones, and is often the place of great socialising and storytelling at the end of the day. The dining area also encourages a 'shared' table approach.

The basement area provides a work bench for ski waxing, a limited number of storage lockers and general maintenance items.

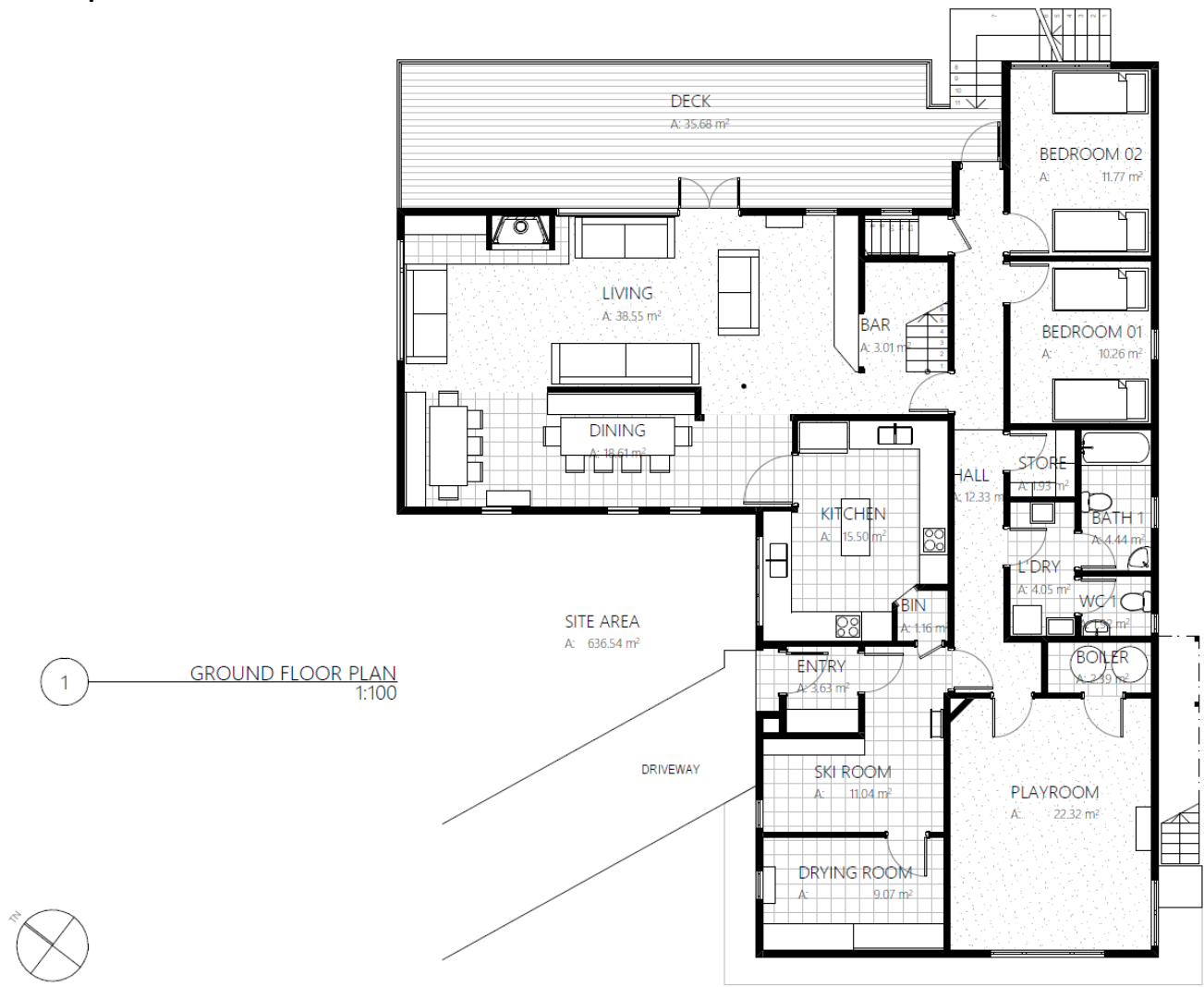
Members are expected to assist with a variety of small tasks around the lodge during their stay. These duties are allocated by the designated Club Captain each week. A cleaner is also employed once a week on changeover day (Normally Saturdays)

Ground Floor plan:

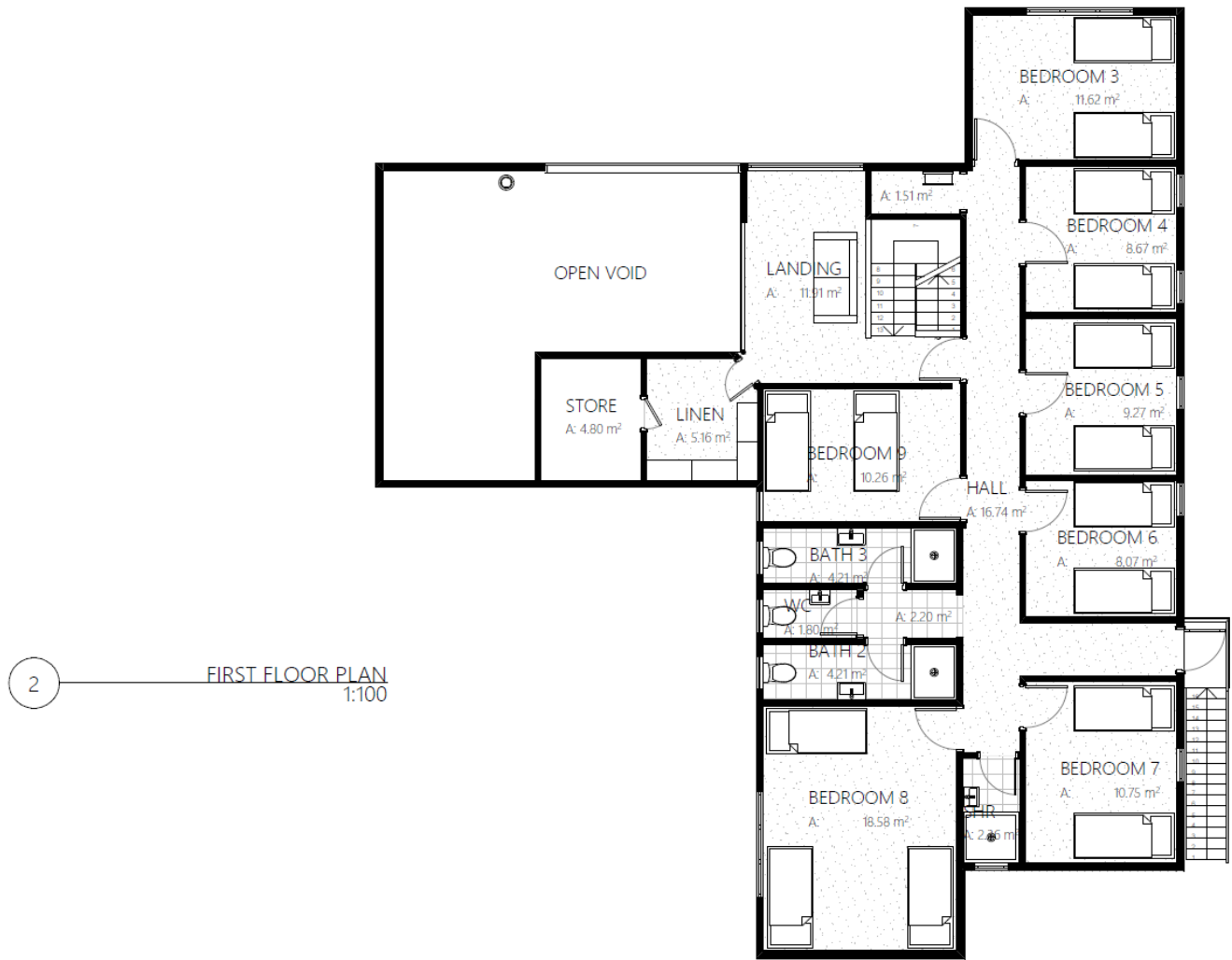

Accommodation bookings

The Ski Club is available for bookings all year round. Prices are lowest over the summer months and then vary over the winter months based on timing within the ski season.

Bookings for members, their partner and children are able to be made from February 1 each year for the winter season, with bookings for guests (attended with a member) open from March 1 each year. Guest bookings must be accompanied by a member.

With the exception of School Holidays, accommodation is on a weekly basis, from Saturday to Saturday. Part week bookings may be made, but are not able to be confirmed until two weeks prior to the booking. The daily rate is 20% of the weekly rate.

School Holidays are broken down into five or six day periods; and if demand exceeds availability, a ballot is undertaken.

Additionally, there are two Whole of Lodge booking weeks generally available. These are also subject to a ballot if there are multiple requests. If these weeks are not booked by April 1, they revert back to a normal week.
